## New Student Health Examination Data Collection Notification and Consent Form

Dear Student,

Welcome to Taipei Medical University (hereinafter referred to as TMU). To promote the health and well-being of TMU students, TMU informs you of the following matters in accordance with the Personal Data Protection Act:

### 1. Name of the collecting agency:

The data you provide is collected by TMU.

### 2. Purpose of collection:

TMU collects your personal data for the execution of new student health examinations to understand student health conditions and related factors, thereby providing improvement suggestions and promoting student health management. The data you provide, including examination data, statistics, images, etc., generated during the new student health examination, will be used internally by TMU personnel for analysis, research, and teaching training purposes; for human research; or for independent or cooperative research and development with related institutions. If there are research and development results, there may be an opportunity to feedback relevant information to you regarding preventive healthcare, thereby enhancing the understanding of student health conditions and promoting student health management. TMU expressly declares that your data will not be used for any other purposes without your consent, except within the aforementioned scope.

### 3. Categories of the personal data to be collected:

The data you provide includes personal registration information and medical, medication, and examination data, statistics, images, etc., from the new student health examination.

### 4. Time period, territory, recipients, and methods of which the personal data is used:

The scope of authorization agreed upon by you in this consent form may include contact, data analysis, statistics, and academic research by TMU; or usage by TMU and other institutions for the purposes of data collection. The utilization will be conducted within the necessary period, territory, and recipients, using reasonable and appropriate methods within the scope of the collection purpose. However, if there are legal regulations, the data will be handled according to those regulations.

### 5. Your rights under Article 3 of the Personal Data Protection Act and how to exercise them:

You have the right to inquire or request to view, make copies, supplementation or correct your personal data, to request to stop collection, processing, or use of your personal data, and to request the deletion of the data you provide. You can notify TMU in writing at any time to exercise these rights. However, when you request

supplementation, correction, or deletion, TMU has the right to review the necessity, accuracy, and legitimacy according to legal regulations. **6. The impact on your rights if you choose not to provide personal data:**

Whether or not you agree to provide data to participate in the research or services mentioned in this consent form will not affect your existing rights to education, medical care, examinations, and other entitlements. However, if TMU conducts research on the related data and you do not agree to provide data, you may not be able to receive feedback on medical developments or related services derived from such research.
